This includes the costs of soliciting, closing, and maintaining the planned gifts. Examples of costs to be coded here include: salary and benefits (either full or fractional staff expense); cost of planned giving advertising; cost of annual planned giving event; cost of planned giving brochures; and travel expenses.		
D94	9400	<u>Development</u> - All staff and expenses related to generation, research, and tracking of prospects. Examples of costs to be coded here include: salary and benefits (either full or fractional staff expense); cost of scoring and modeling prospects; and cost of information services.		
D95	9500	<u>Development</u> - All staff and expenses related to production, cultivation, and solicitation of gifts by membership. Examples of costs to be coded here include: salary and benefits (either full or fractional staff expense); cost of membership benefits; cost of solicitations such as direct mail, telemarketing, and cost of annual awards dinner. This category applies to memberships of any dollar amount.
